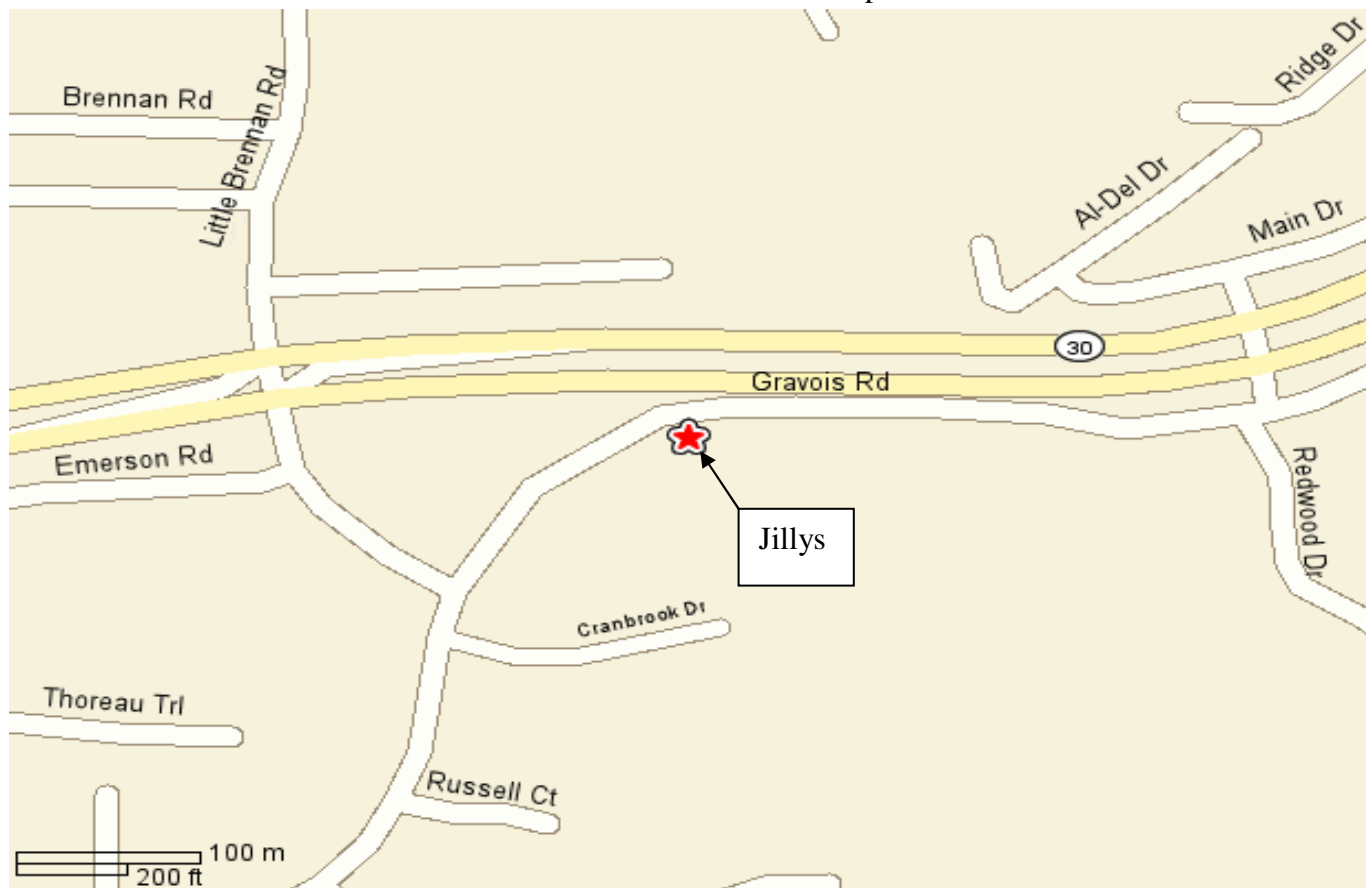
**Happy New Year!**
