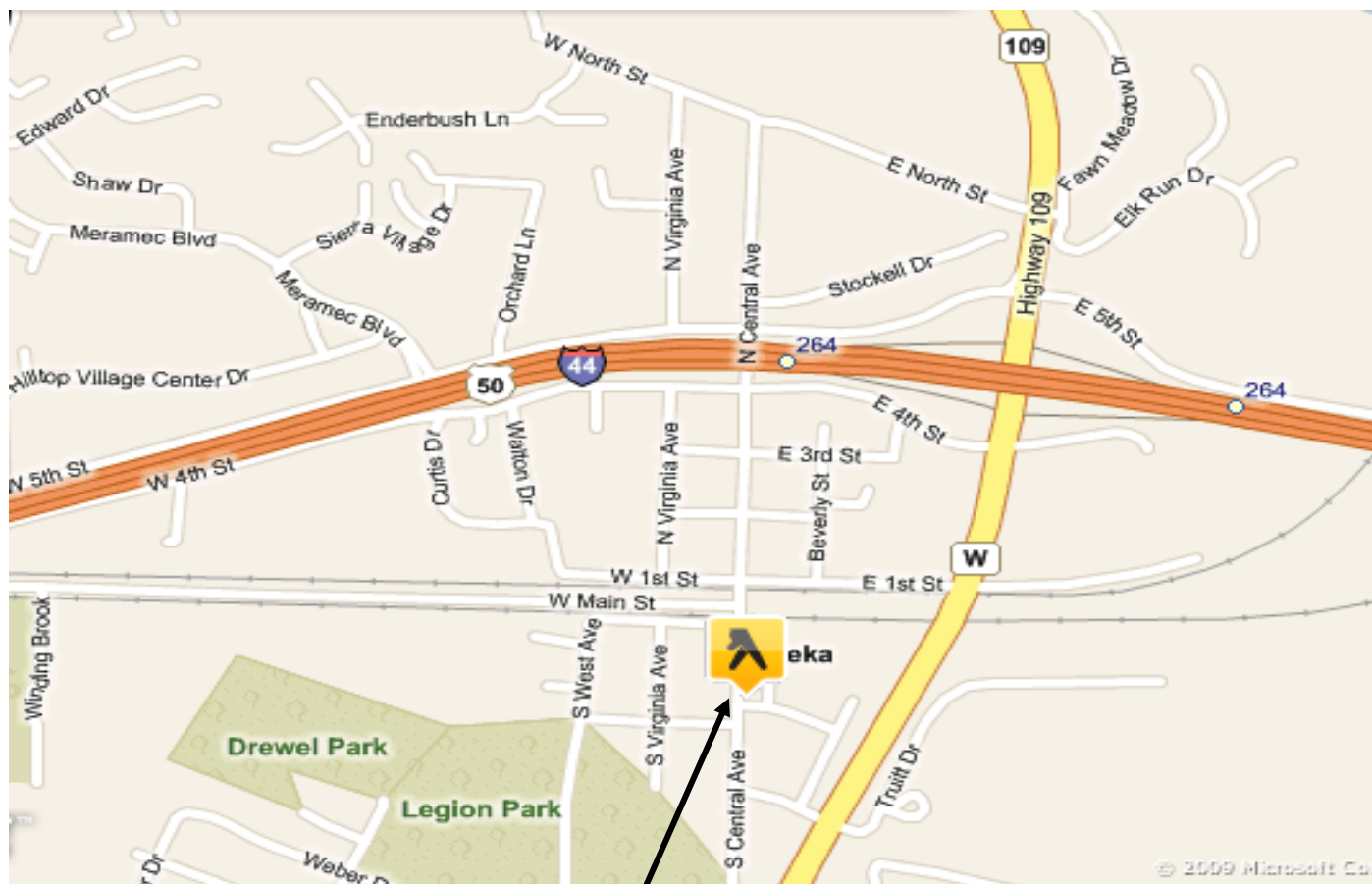
Happy New Year!

Saturday night will be the same motel and school gym lodging as in the past. There are no hook ups for electric, sewer, or water and not much shade. Basically, camping is in an open field. We do have a nice shower and restrooms, water, and RV dump station.

As before, we will provide Saturday lunch, dinner at the Country Club, Sunday breakfast buffet and BBQ lunch by the Boy Scouts, as well as fuel along the trail.

We are not open to the public and this is not a spectator event. Only participants will be allowed access to the property. If you are bringing a non-participant travel companion, they are welcome to camp with you for free but will need to go through sign up and sign the appropriate release and waiver. If a non-participant will be joining you for the evening meal on Saturday night, you need to indicate this on your application so that we can plan accordingly, and there will be a charge for that meal.
